## The Happy Valley Adventure Bureau names new Board officers, members

Dave Capperella to serve as HVAB Board Chair

She cited among the highlights of her tenure the formation of the Happy Valley Sports & Entertainment Alliance and the hiring of its first Executive Director, Eric Engelbarts; and the exciting new partnership between Penn State Athletics and the HVAB, which has helped bring high-profile events to the region, including the iconic Luke Combs concert and the inaugural Hoppy Valley Brewers Fest.
